	FDA Registration of Food Facilities: All food manufacturing facilities are required to be registered and update info according to: "Section 415(a)(3) of the FD&C Act requires facilities that are required to register with FDA to renew their registrations every other year, during the period beginning on October 1 and ending on December 31 of each even-numbered year." O This is where to go to log in and renew registration as a food manufacturing

You also need to fill out your paperwork to apply for/maintain your exemption to the Food
Safety Modernization Act (FSMA) rule if you meet the requirements. This makes you exempt
from an FDA FSMA inspection but not Vermont's. If applicable to you, apply for/apply to renew
for FSMA exemption.
